Intersection/Location	Situation	Response
Pacific St & I-680 NB off ramp	Traffic backing up in left turn lanes	Use secondary route: Divert traffic to right turn onto Pacific St Divert I-680 traffic to W Center Rd at Exit 1 and Exit 445
120 th St & Pacific St	Traffic backing up at intersection	Use secondary route: Divert traffic at Pacific St & I-680 NB off ramp to right turn onto Pacific St Divert I-680 traffic to W Center Rd at Exit 1 and Exit 445
120 th St & US-6 (W Dodge Rd)	Traffic backing up in right turn lane	Use secondary route: Divert traffic at Pacific St & I-680 NB off ramp to right turn onto Pacific St Divert I-680 traffic to W Center Rd at Exit 1 and Exit 445 (DO NOT USE 120 th ST)

Typical Situation	Potential Response(s)
Incident Located on Shoulder or Off of Roadway Expected Duration < 30 min	
Shoulder and/or one outside lane blocked	On scene traffic control only
No lanes blocked	Do nothing
Incident Located on Roadway Expected Duration < 2 hour	
All lanes blocked	Full diversion
One outside lane and one inside lane blocked	Advanced warning using three upstream DMS Advise using alternate route
One inside lane blocked	Use spotter to direct traffic Advanced warning using two upstream DMS
Shoulder and/or one outside lane blocked	On scene traffic control Advanced warning using one upstream DMS
Incident Located on Roadway Expected Duration > 2 hour	
All lanes blocked	Full diversion
Hazardous material spill	
Fatality	
Multi-vehicle/multiple incidents (close proximity)	
More than two lanes blocked including one or more inside lanes	Partial diversion Use DMS to have through traffic use global detour Divert one or more lanes of traffic onto local detour
One outside lane and one inside lane blocked	Set up cones/barricades to restrict lanes Advanced warning using upstream DMS Advise using alternate route
