Incident Located on Roadway Expected Duration < 2 hour	
All lanes blocked	Full diversion
Inside lane blocked	Use spotter to direct traffic Advanced warning using two upstream DMS Advise using alternate route
Shoulder and/or outside lane blocked	On scene traffic control Advanced warning using one upstream DMS
Incident Located on Roadway Expected Duration > 2 hour	
All lanes blocked	Full diversion
