

Minor Impact to Traffic (Less Than 30 Minutes)

Off Peak –	Diversion not implemented:

Intermediate Impact to Traffic (30 Minutes to 2 Hours)

Off Period – Shoulder and One Lane Blocked	 Deploy informational DMS messaging for approaching traffic
Peak Period – Shoulder and One Lane Blocked	 Partial Diversion: On-scene traffic control Deploy informational DMS messaging for approaching traffic Deploy DMS messaging directing through traffic to use diversion routes Monitor local diversion routes at critical locations as needed
